CONDITIONS OF SERVICE

- ★ In an effort to improve our efficiency and prevent launch delays, please return this checklist by March 1, 2009. Our launch schedule is filled as we receive these check lists. If your selected week is booked we will schedule you in the next open week. We do not guarantee a Launch Date but work to the best of our ability to meet your date.
- ★ Again, in order for work to be started we must have a signed, completed Spring Checklist. It is also important to fill in the requested launch date. The Spring Checklists and requests for work will generally be assigned on a first come-first serve basis. The spring season is always a very busy time and the launch crew can only launch a limited number of boats per week. Short notice work requested at launch time may require overtime billing. Normal Labor rates are \$65.00 to \$110.00 per hour. Time is based on actual time craftsman is dispatched from the office until he reports the work completed.
- ★ Keys or combination must be available in office or lock will be cut and a new lock will be installed at the owner's expense. Combination locks are strongly recommended to save time and costs.
- ★ Fenders and dock lines must be left on board or a delay in launch may result.
- ★ All batteries must be on board prior to launch date. If batteries are not on board additional charges may result.
- ★ Boats without slips at the yard will have three free days of dockage after the boat is launched. Any boats staying longer than three days will be charged at transient rates. Arrangements should be made with the yard office for extended dockage.
- ★ No boat will be launched unless the area surrounding the boat is clean and clear of debris.
- ★ Bottom sanding must be done with a dustless sander system.
- ★ The owner shall be responsible for the vessel's safety and have insurance coverage for the vessel after its post launch check.
- ★ It is illegal for boat owners to apply antifouling paint in a New York boatyard without yard permission. (N.Y.S.D.E.C. ruling). We do not allow owners to apply pesticides on our property.
- ★ The owner acknowledges that the yard makes no representation regarding the adequacy of water levels for egress or ingress.
- ★ Any bilge pumping or pumps required at launch will be billed at normal rates.
- ★ Brewer Yacht Yard will not supply any ladders or staging, boat owners are responsible for this equipment and use it at their own risk. DO NOT USE FENCES AS LADDERS, YOU WILL BE CHARGED FOR NEW RAILS.
- ★ NO OUTSIDE LABOR or independent contractor is allowed unless prior permission is obtained from the yard office. The yard reserves the right to: require proof of adequate liability insurance, require a fee to be paid to the yard for their activities, hold the owner responsible for the activities of the contractor and other signing in and out requirements.
- ★ The owner agrees to adhere to all State and Federal rules and laws and will be responsible for misuse.
- ★ The yard provides no security protection and assumes no responsibility for person or property.
- ★ Overboard discharge of heads or holding tanks within the marina is strictly prohibited.
- ★ PREFERRED CUSTOMER CARDS: May be picked up in the dock office after all bills are paid
- ★ BEWARE: THE VESSEL AND ITS CONTENTS MAY BE SOLD AT AUCTION FOR FAILURE TO PAY STORAGE CHARGES.
- ★ ACCRUED WINTER CHARGES AND SUMMER SLIP FEES MUST BE PAID BEFORE THE BOAT IS LAUNCHED.
- ★ THE BOAT OWNER SHALL BE PERSONALLY RESPONSIBLE TO BREWER YACHT YARD, INC. FOR ALL ATTORNEY FEES INCURRED BY BREWER YACHT YARD, INC., TO COLLECT ON ANY OUTSTANDING BALANCES DUE TO BREWER YACHT YARD, INC., AND FOR ALL ACTIONS AND CLAIMS IN REGARDS TO PLACING AND ENFORCING MECHANICAL LIENS AGAINST OWNER'S BOAT AND PROPERTY FOR COLLECTION OF ANY OUTSTANDING BALANCE DUE TO BREWER YACHT YARD, INC.
- ★ SPRING COMMISSIONING CHARGES ARE DUE WHEN RENDERED, AND ACCOUNTS FOR NON-MARINA CUSTOMERS ARE DUE PRIOR TO DEPARTURE. A 1.5% SERVICE CHARGE PER MONTH (18 % ANNUALLY) WILL BE ADDED TO BALANCES PAST 30 DAYS DUE AND THE CUSTOMER WILL BE RESPONSIBLE FOR ALL COLLECTION EXPENSES.
