CONDITIONS OF SERVICE

- In an effort to improve our efficiency and prevent launch delays, please return this checklist by March 15, 2009.
- In order for work to be started we must have a signed, completed Spring Checklist. It is also important to fill in the requested launch date and sail-away date. Request for work will generally be assigned on a first come- first serve basis. The spring season is always a very busy time and the launch crew can only launch a limited number of boats per week.
- Labor rate is \$89.00 per hour. Time is based on actual time the craftsman is dispatched from the office until he reports the work completed.
- Keys or a combination must be available in the office or the lock will be cut and a new lock will be installed at the owners expense. Combination locks are strongly recommended to save time and costs.
- Fenders and dock lines must be left on board or a delay in launch may result.
- All batteries must be on board prior to launch date. If batteries are not on board additional charges may result.
- Boats without slips at the yard will have three free days of dockage after the boat is launched. Any boats staying longer than three days will be charged at transient rates. Arrangements should be made with the yard office for extended dockage.
- No boat will be launched until the area surrounding the boat is clean and clear of debris.
- The owner shall be responsible for the vessel’s safety and have insurance coverage for the vessel after its post launch check.
- The owner acknowledges that the yard makes no representation regarding the adequacy of water levels for egress or ingress.
- **NO OUTSIDE LABOR** or independent contractor is allowed unless prior permission is obtained from the yard office. The yard reserves the right to: require proof of adequate liability insurance, require a fee to be paid to the yard for their activities, hold the owner responsible for the activities of the contractor and other signing in and out requirements.
- The owner agrees to adhere to all State and Federal rules and laws and will be responsible for misuse.
- The yard provides no security protection and assumes no responsibility for person or property.
- Overboard discharge of heads or holding tanks within the marina is strictly prohibited.
- **BEWARE -THE VESSEL AND ITS CONTENTS MAY BE SOLD AT AUCTION FOR FAILURE TO PAY STORAGE CHARGES.**
- **ACCRUED WINTER CHARGES AND SUMMER SLIP FEES MUST BE PAID BEFORE THE BOAT IS LAUNCHED.**
- **SPRING COMMISSIONING CHARGES ARE DUE WHEN RENDERED, AND ACCOUNTS FOR NON-MARINA CUSTOMERS ARE DUE PRIOR TO DEPARTURE. A 1.5% SERVICE CHARGE PER MONTH (18% ANNUALLY) WILL BE ADDED TO BALANCES PAST 30 DAYS DUE AND THE CUSTOMER WILL BE RESPONSIBLE FOR ALL COLLECTION EXPENSES. A 1.5% ENVIRONMENTAL CHARGE WILL BE APPLIED TO ALL CHARGES. THIS IS NOT A GOVERNMENT FEE BUT ASSISTS IN PAYING PART OF THE COST OF ENVIRONMENTAL COMPLIANCE.**
